✓ Notify Utilities & Important Contacts

Update:

- Banks & insurers
- Employer
- Schools
- GP/Dentist
- Broadband & TV services

Arrange utilities (gas/electric/water) for your new home.

✓ Prepare Your Home

Empty lofts and sheds, use up frozen food, group small items together.

2 Weeks Before Moving

✓ Finalise Details

Confirm:

- Notify service providers
- Arrange for post to be redirected
- Transfer phone numbers – where required
- If you are packing yourself, assess whether you need more assistance and or packing materials

- ✓ **Start Packing Non-Essentials (if you are packing prior to the move)**

Pack books, spare bedding, décor, toys, and seasonal items.

1 Week Before Moving

- ✓ **Prepare an Essentials Box**

Include: kettle, cups, toiletries, chargers, bedding, snacks, documents.

- ✓ **Make sure all vital documents are together and safe for moving**

- ✓ **Defrost Your Freezer**

Do this 24-48 hours before moving day.

- ✓ **Check Garage, Sheds, Attic & Basements for any items that may have been overlooked.**

Moving Day

- ✓ **Meet Your Moving Team**
